Meeting called to order by Commissioner Knopf at 5:35 PM

II. INTRODUCTIONS

III. APPROVAL/CORRECTION OF MINUTES

Commissioner Knopf asked that the minutes change the wording where applicable from “motion was made” to “it was moved”. Commissioner Rones moved minutes of June 17, 2014 PRGC be approved as amended, seconded by Commissioner Sadowski. Passed.

IV. AUDIENCE COMMENTS ON NON-AGENDA ITEMS

Greg Etter, a social entrepreneur intern with VISTA, requested to make a short presentation to the PRGC on behalf of FIRST 5 Mendocino, a local organization that funds various children’s programs throughout Mendocino County funded through California Proposition 10 (tobacco tax). The funding for FIRST 5 is slowly dwindling due to a fortunate decline in the number of people smoking.

Mr. Etter stated from their talk with parents there is a lack of family-friendly, fun activities in Ukiah and the surrounding county. FIRST 5 is proposing to create a “family-fun business” through either a batting cage facility or a community miniature golf course to help sustain an organization that wants to continue helping the community it serves.

Following a short discussion, Commissioner Rones expressed to Mr. Etter that a batting cage and miniature golf course had opened previously in Ukiah, and a driving range (though not necessarily a family oriented business) had been explored. Unfortunately, none of these enterprises were successful. Commissioner Rones asked what advice he was seeking from the Commission. Mr. Etter was interested ideas and opinions.

Commissioner Knopf summarized the commissioner’s comments by stressing how important it was to do extensive research on how large of a population was needed to generate the traffic to make any of the proposed businesses viable.

Recreation Supervisor Young expressed it was also very critical to have an expert in the particular field of recreation as well as a person who is highly experienced in organized recreational activities delivered by cities, schools or non-profit organizations.

Commissioner Knopf asked if he was in contact with West Company, a non-profit that works closely with government supported small-business development. Mr. Etter said he was and had an appointment scheduled. The commissioners highly recommended the West Company and said he would find them very helpful. The commission thanked him and wished him the best.

He thanked the commissioners for their time and appreciated the support and the value of their opinions in the work he was doing with FIRST 5.

VI. OLD BUSINESS

A. Update on Recreation Programs and Events

Recreation Supervisor Young reported on current and upcoming events and activities of the Park and Recreation Department. She also responded to the questions asked at the last meeting.

- Session III began yesterday (July 14)= 165 students.

- Pool slide installation scheduled to begin July 16, 2014.

Upcoming

- Working on the Fall Recreation Guide offerings and PumpkinFest.

Discussion:

- **PumpkinFest**

Commissioner Susan Knopf asked if the PumpkinFest has been evaluated; if it was worth the staff time focused on the event at the expense of other activities and commitments of the Department? Her question concerned the resources spent on the event relative to the return.

Recreation Supervisor Young responded that months of preparation are spent on the PumpkinFest and that the PumpkinFest Committee met monthly, year-round planning the event.

Commissioner Rones said it has a large out-of-town draw. Commissioner Sadowski said he had a booth for his business each year and he believed it was the largest event that the City of Ukiah sponsors and the largest event inside the City Limits. There were no other questions or comments.

- **Changing Room: Todd Grove Park**

Last month, the Commission discussed again the possibility of an adult changing station for developmentally disabled adults requiring assistance in personal care while using the Park. At the last meeting it was asked if the former park restroom now being used for office and storage by Summer Safari Day Camp could be converted to such a facility. Recreation Supervisor Young said that building was in full use and it wasn't practical to relocate.

Commissioners agreed if there were widespread demands, another facility should be converted (or built, perhaps adjacent to the existing park rest room). It was pointed

out that the Municipal Golf Course allowed those who need comfortable and convenient ADA access, that their restrooms in the clubhouse are available to park users. Commissioners agreed that special accommodations as described were desirable, but for now, any further accommodations beyond ADA requirements were not affordable.

Orchard Park Signage:

Commissioner Knopf had asked why there was not a City Sign identifying Orchard Park. Some Commissioners thought there had once been a sign. Recreation Supervisor Young was not aware that a sign wasn't in place and that she would redirect the question to lead grounds worker Jarrod Meyer and return with an answer at for the commissioners at the next business meeting,

B. Replacement of Group Picnic Areas; Todd Grove and Vinewood Park

Recreation Supervisor Young reported that the grant application to the California Housing and Community Development Agency for renovation of the Todd Grove and Vinewood Park group picnic areas had been approved and funded for \$142,000. Commissioner Rones asked what the money was specifically allocated for. How was it restricted? Recreation Supervisor Young said she was not familiar with all the particulars; however she would attempt to get copies of the grant application for Commissioners to review. Commissioner Knopf understood the City Council approved the hiring of the planner/developer for the City parks. Recreation Supervisor Young said that was correct, it was approved in the budget and it would be that person's responsibility to implement the grant. Commissioner Knopf was on the selection committee and asked if there was any further information on when that selection process may begin. Recreation Supervisor Young stated that it should be very soon; that the approval for recruitment would be before the City Council and Commissioner Knopf would be notified when the selection committee was convened.

C. Status of PRGC membership

Recorder Bradley distributed the Draft City Council Agenda Summary Report (ASR) with the changes proposed by the PRGC and approved last month. The Commission reviewed the

documents. Commissioner Knopf pointed out discrepancies in the number of commission members in Section 1001. Recorder Bradley agreed and would make the corrections. Commissioner Knopf also requested that in the first paragraph of page two of the (ASR) include more than one example of “increased need for diverse representation” such as the swimming pool, hiking trails, Alex Rorabough Center. Recorder Bradley said he would revise the sentence. Recorder Bradley asked if there was no reference to golf included the revised City Code Section, should the PRGC retain “Golf” in the Commission’s name. After a brief discussion, it was agreed to wait until all commissioners were present before making a decision, and to move ahead with forwarding the membership recommendations to the City Council.

VII. COMMISSIONER’S COMMENTS

Recreation Supervisor Young reported that Grace Hudson Museum Director invited the Commission to have their next meeting at the Sun House Museum to receive a report on the progress on the Outdoor Exhibit development. The presentation would be conducted by Director Smith-Ferri and Project Analyst Katie Marsolan and it was suggested that the PRGC suspend their business agenda to devote the full meeting to review of the outdoor exhibit design as well as the programmatic content. The Commissioner’s all agreed.

There were no additional Commissioner Comments.

VIII. Adjournment

Commissioner Ronnes moved that the meeting be adjourned, seconded by Commissioner Sadowski.
