## City of Ukiah's Vendor Terms and Conditions

### VENDORS AGREE TO THE FOLLOWING:

---

1. Submit a completed City of Ukiah Vendor Booth Application with booth fee prior to deadline.
2. Follow all local, state and federal laws, regulations, and guidelines for food and beverage service and handling and any other laws governing this type of activity including but not limited to receiving a **temporary food facility permit from the County of Mendocino Environmental Health Division**.
3. Provide the City of Ukiah with a **Certificate of Insurance and Additional Insured Endorsement** (Form CG 20 26 11 85) naming the City of Ukiah as additionally insured in the amount of \$1,000,000 (one million dollars). City forms will be provided upon request.
4. Be set-up and ready to serve Car Show attendees by 7:00am. The Vendor agrees to keep booth open during the full day from 7:00am-4:00pm. Your assigned area will be posted. Each vendor will be assigned to a designated area. Do not move from assigned area.
5. Provide the following: tables, chairs, shade, display devices. Tables and Chairs will not be provided.
6. City agrees to provide large waste dumpsters at various event locations.
7. The Vendor agrees to maintain cleanliness of their booth and surrounding area throughout the hours of the event, to perform a thorough clean-up at the end of the day. Vendors agree to dump waste in the provided dumpsters at the end of each day of the event. Food vendors must take grease or similar by-products with them. No dumping of hazardous waste allowed.
8. City agrees to provide adequate event promotion, but shall not guarantee a minimum attendance, nor shall guarantee minimum sales activity to Vendor.
9. Vendor shall assume risk of weather or other causes beyond the control of the City, which may affect event attendance in any way. City *may* make such provision for alternate locations, but *does not guarantee* such alternatives will be made available.
10. City shall furnish ample security during specified times for the event in general. Vendor is solely responsible for any damage or losses of product incurred as a result of participation in the events and activities.
11. The City of Ukiah has procedures and policies for conducting business within the City limits. All sellers must have a valid sellers permit and/or business license as applicable.
12. Electricity is available on a very limited basis. You must bring your own 50' heavy duty outdoor extension cord and duct tape. **IF YOU REQUIRE ELECTRICITY, YOU MUST ADVISE US WITH INITIAL APPLICATION - FOR FOOD VENDORS ONLY.**
13. The undersigned and the organization he/she represents (applicant) shall fully indemnify, defend and hold harmless the City of Ukiah, and its officers, employees and agents (collectively, the City) against any expense or liability in connection with a claim for damages against the City (claim) which arises out of applicant's use of a booth at the Car Show. Applicant will pay all costs incurred by City or required to defend City against any claim, including, but not limited to, court-related fees, litigation expenses, and the fees of attorneys, experts, expert witnesses and consultants. Applicant will pay the full amount of any settlement of a claim by the City or judgment against the City resulting from a claim.
